### Implementation of Delegated Access and iLinkBlue MFA

# Dear Provider:

In June, we experienced unexpected challenges during the deployment of the new iLinkBlue security changes and had to pause implementation of the new security setup tool and multi-factor authentication (MFA). Blue Cross and Blue Shield of Louisiana understands the importance of iLinkBlue to our providers and for this reason it is equally important to us that you have the best user experience; even when transitioning to new security protocols.

Since June, we have worked to ensure no further issues will cause inconvenience to our iLinkBlue users upon deployment of the new Delegated Access security application and multi-factor authentication process for login. Use the chart below to identify important implementation dates.

Date	Security Change
August 30, 2022	Blue Cross will stop setting up new administrative representatives in the existing Sigma Security Tool. This is in preparation for migrating data to the new security setup application called Delegated Access.
_	If you need to designate a new administrative representative to use Sigma before it is disabled, please do so before August 30. Registration packets are available online at <a href="https://www.bcbsla.com/providers">www.bcbsla.com/providers</a> > Designate Your Rep.
September 2 – 8, 2022	The Sigma Security Setup Tool will be disabled. During this time, administrative representatives, as well as our Provider Identity Management (PIM) Team, will not be able to make any security access changes.
September 9, 2022	The new Delegated Access application will be available to administrative representatives. It must be accessed through iLinkBlue. Administrative representatives and our PIM Team can begin making security setup changes using the new application.
	MFA verification will be required for all iLinkBlue users to securely log into iLinkBlue ( <a href="www.bcbsla.com/ilinkblue">www.bcbsla.com/ilinkblue</a> ). It is a security feature that authenticates who you are and is done through the delivery of a unique identifier code, based on your preference of delivery.

# **Preregister for MFA**

iLinkBlue users should preregister now to indicate their preferred MFA verification methods. Please preregister **at least two methods** of verification (email, text, voice call and/or smartphone app). Note: If you previously registered with PING for MFA verification, you do not have to register again.
